## **CONDITIONS OF APPROVAL**

**Development Permit Number: DP24-017**

1. **All portions of the sign must be located upon the site for which this Development Permit has approved.**
2. Any sign no longer advertising a genuine business or service on these premises must be removed by the property within sixty (60) days of termination of the business or service.
3. The approved signage is permitted within the Registered Right of Way in accordance with the location specified within the approved plans submitted by the Applicant.
4. **No portion of any sign may encroach onto Town-owned land, or Provincial highway right-of-ways.**
5. Please ensure all contractors have or obtain an approved Town of High Level Business License prior to commencing the development
6. The Registered Owner or Lessee of the property where this sign is located must not allow the sign, it's supports, electrical system or anchorage to become unsightly.
7. The signage shall not be altered, changed or modified from the approved plans and specifications without written authorization from the Development Authority.
8. **The sign approved is a portable sign (5 x 9 feet).**
